- H. Scripts:** Please send one copy of an original script (booklet from a publisher) to each Critic Judge. Please mail it by February 23, 2018. A reminder that a UIL rule requires the director to present a script to the contest manager before the rehearsal is started along with proof of royalty payment, etc. This script shall represent exactly what is being performed. The script must be an original from the publisher (no copies made by a copy machine are allowed due to copyright) unless it is public domain.
- I. Entry Deadline:** The entry deadline is February 26, 2018. Please remember to enter your students on the UIL online entry system along with the paper entry forms.
- J. Set and Strike:** Details will be given during rehearsals.
- K. Lighting:** Details will be given during rehearsals. Directors may set light cues ahead of time by visiting the host school. Be sure to schedule a time with the host site and the contest manager. You can also set lighting cues during your site rehearsal or run the board manually.
- L. Sound:** Your crew must operate any sound your show requires. Schools may bring their own sound equipment.

 2. 2" Silver All-Star Cast medals for 8 places
 3. One 2" gold Best Actress medal
 4. One 2" gold Best Actor medal

 6. Three 9x12 plaques for District One-Act Play Advancing Plays,
 7. 2" gold medals for Advancing Casts and Crews (75)
 8. 2" gold medals for All Star Crew
 9. One 8x10 plaque for District Outstanding Technical Company
 10. 2" gold medal for Best Male Technician
 11. 2" gold medal for Best Female Technician
