- 2. Blind pairings. Draw for school number at the registration time.
- 3. Each team should hit an A, B, and a C (or as close as possible).

We will provide **3 tables** on one side of the Gym (One table for District 24AAA, one for District 25AAAA and one table for District 24AAAA for **Drawing for Topics**). Gena Smith (24AAA) will supervise the drawing for topics for District 25AAAA, Julie German (26AAAA) will supervise the drawing of topics for District 25AAAA and Erin Moore (25AAAA) will supervise the drawing of topics for District 24AAA.
